

Privacy

Watford Park u3a (WPu3a) treats your privacy rights seriously. This Privacy Policy sets out the basis on which we collect and use personal data about you.

Personal Data

In this Privacy Policy, where we use the words 'personal data' we use these words to describe information that is about you and which identifies you.

This Policy describes:

- who is responsible for the personal data that we collect about you;
- the personal data we collect about you;
- how we will use it;
- who we may disclose it to;
- your rights and choices in relation to your personal data.

This is to make sure you have a full picture of how we collect and use your personal data.

Who is responsible for the personal data that we collect?

We are the data controller for the purposes of data protection law, in respect of your personal data collected and used by us.

What personal data do we hold about you?

We collect and use personal data about you for the purpose of communicating with you as representative of your u3a. The personal data we hold includes information that you provide to us or we collect from you.

This information may include the following:

<u>Type of Personal Data</u>	<u>Examples</u>
Information to enable us to communicate with you and to manage your membership	When you express an interest in becoming a member of WPu3a you will be asked to provide certain information. This includes: <ul style="list-style-type: none">• your name• home address• email address• telephone numbers• emergency contact details• your tax situation (for Gift Aid)• membership of other u3as
Other Information	Once you are a member of WPu3a you will have access to your profile, on our website, to provide further information, which is voluntary, but which we may nevertheless use to provide services to you.

<u>Type of Personal Data</u>	<u>Examples</u>
Technical information	<p>Certain information is collected by most websites or automatically through your electronic device, such as your IP address (i.e. your computer's address on the internet), screen resolution, operating system type (Windows or Mac) and version, internet browser type and version, electronic device manufacturer and model, language, time of the visit and pages visited.</p> <p>Cookies are pieces of information stored directly on the device you are using to access our website. Cookies allow us to recognise your device and to collect information such as IP address, internet browser type, time spent using the website and the pages visited.</p>

This information may be provided:

- in the course of communications between you and us (including via our website, by phone, email or otherwise);
- when you provide personal data via our websites or using other systems which we provide to you;
- via any social media pages, other social media content, tools and applications.

Information about third parties

In the course of us communicating with you, you may provide us with personal data relating to third parties. We will use this personal data in accordance with this Privacy Policy. If you are providing personal data to us relating to a third party, you confirm that you have the consent of the third party to share such personal data with us and that you have made the information in this Privacy Policy available to the third party.

How do we keep the personal data we collect from you?

We store the information collect from you in our Simple Membership database, which is operated and managed by Web Integrate Ltd (Company Number 06857067), under the provisions of their Simple Membership Privacy Policy. That policy is available on our website, alongside this policy.

How do we use the personal data we collect about you?

We use your personal data for a variety of different purposes during the course of us providing services to you. The purposes for which we use your personal data are set out below. Under data protection law, we can only use your personal data if we have a legal basis to do so. Examples of where we have a legal basis to process your personal data, includes when:

- we have your consent;
- it is necessary to enter into or perform a contract we have with you (or to take steps at your request prior to entering into that contract);
- it is necessary to comply with a legal obligation; or
- it is in our legitimate interests to process your personal data.

Legal Basis

We have set out our reasons for using your personal data in the table below. Where we rely on our legitimate interests, we have set out those interests in the table below.

To deliver Third Age Trust publications including Third Age Matters	Contract Legitimate interests
To comply with any legal or regulatory obligations (including in connection with a court order)	Legal obligation
To enforce or apply the agreements concerning you (including agreements between you and us).	Contract Legitimate interests
To manage any issues, complaints, feedback and enquiries.	Consent Contract Legitimate interests
To reclaim tax from HMRC via Gift Aid	Consent Contract Legitimate interests

We do not use your personal data to make any automated decisions that might affect you.

Who may we disclose your Personal data to?

We may share your personal data with:

- the Third Age Trust
- HMRC
- our service providers and business partners

For more information please refer to Schedules 1 and 2.

We may also disclose your personal data to other third parties, for example:

- if we or substantially all of our assets are acquired by a third party (or we are subject to a reorganisation), personal data held by us will be one of the transferred assets;
- if we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our agreements concerning you (including agreements between you and us).

Where will we transfer your personal data?

If we transfer personal data outside the UK, we will implement appropriate and suitable safeguards to ensure that such personal data will be protected as required by applicable data protection law.

How long will we keep your personal data?

We will keep your personal data for different periods depending on the nature of the information, the purpose for which it was collected, any legal obligation and/or business reason to retain.

The above retention period(s) may be extended where we need to preserve and use personal data for the purposes of bringing or defending a legal claim. In such cases, we will continue to hold and process your personal data for as long as is necessary to deal with the legal proceedings.

What are your rights?

You have certain rights with respect to your personal data. The rights will only apply in certain circumstances and are subject to certain exemptions. Please see the table below for a summary of your rights. Details of who to contact to exercise these rights can be found below.

<u>Summary of your rights</u>	
Right of access to your personal data	<p>You have the right to receive a copy of your personal data that we hold about you and information about how we use it, subject to certain exemptions. Your personal data can be viewed in your Profile on the WPU3a website. Alternatively, you can make this request by contacting the Membership Secretary. We will usually respond within one month of the request being made.</p> <p>There may be certain circumstances where we are not able to comply with this request. This would include where the information may contain references to other individuals or for legal, investigative or security reasons.</p>
Right to rectify your personal data	<p>You have the right to ask us to correct your personal data that we hold where it is incorrect or incomplete.</p> <p>To ensure the information we hold is accurate and up to date, members should review their Profile on the WPU3a website on a regular basis, and make any changes that are necessary. You can also do this by contacting the Membership Secretary.</p>
Right to erasure of your personal data	<p>You have the right to ask that your personal data be deleted in certain circumstances. For example:</p> <ul style="list-style-type: none"> • where your personal data is no longer necessary in relation to the purposes for which it was collected or otherwise used; • if you withdraw your consent and there is no other legal ground for which we rely on for the continued use of your personal data; • if you object to the use of your personal data (as set out below); • if we have used your personal data unlawfully; or • if your personal data needs to be erased to comply with a legal obligation. <p>Please note that without access to your personal data it will not be possible for us to be able to provide any services to you, and therefore your membership of WPU3a will lapse.</p>

<u>Summary of your rights</u>	
Right to restrict the use of your personal data	<p>You have the right to suspend our use of your personal data in certain circumstances. For example:</p> <ul style="list-style-type: none"> • where you think your personal data is inaccurate but only for so long as is required for us to verify the accuracy of your personal data; • the use of your personal data is unlawful and you oppose the erasure of your personal data and request that it is suspended instead; • we no longer need your personal data, but your personal data is required by you for the establishment, exercise or defence of legal claims; or • you have objected to the use of your personal data and we are verifying whether our grounds for the use of your personal data override your objection. <p>Please note that without access to your personal data it will not be possible for us to be able to provide any services to you, and therefore your membership of WPu3a will lapse.</p>
Right to data portability	<p>You have the right to obtain your personal data in a structured, commonly used and machine-readable format and for it to be transferred to another organisation, where it is technically feasible for us to do this.</p> <p>The right only applies:</p> <ul style="list-style-type: none"> • to personal data you provided to us; • where we rely on the following legal bases: <ul style="list-style-type: none"> • consent; or • for the performance of a contract; and • when the use of your personal data is carried out by automated (i.e. electronic) means.
Right to object to the use of your personal data	<p>You have the right to object to the use of your personal data in certain circumstances and subject to certain exemptions. For example:</p> <ul style="list-style-type: none"> • where you have grounds relating to your particular situation and we use your personal data for our legitimate interests (or those of a third party); • if you object to the use of your personal data for direct marketing purposes; and • where we use your personal data to take a decision which is based solely on automated processing where that decision produces a legal effect or otherwise significantly affects you.
Right to withdraw consent	<p>You have the right to withdraw your consent at any time where we rely on consent to use your personal data.</p> <p>Please note that without access to your personal data it will not be possible for us to be able to provide any services to you, and therefore your membership of WPu3a will lapse.</p>

Summary of your rights

Right to complain to the relevant data protection authority

You have the right to complain to the relevant data protection authority, which in the case of us is the Information Commissioner's Office (ICO), where you think we have not used your personal data in accordance with data protection law. The ICO's contact details are:

WHO IS PERSONAL DATA SHARED WITH?

Type of third party	Examples
<u>General</u>	
Our service providers and business partners	Our business partners, suppliers and sub-contractors for the performance of any contract we enter into with you (see Schedule 2)
Our professional advisers	Including accountants, lawyers and other professional advisers that assist us in carrying out our business activities.
Government authorities and third parties involved in court action	External agencies and organisations (including the police and other law enforcement agencies) for the purpose of complying with applicable legal and regulatory obligations.
<u>Law Enforcement and Regulation</u>	
Police and law enforcement agencies	We may share personal data with the police and other law enforcement agencies in connection with the prevention and detection of crime
Regulatory bodies	We may share personal data with third parties if we are under a duty to disclose or share your personal data in order to comply with any legal obligation or instructions of a regulatory body (including in connection with a court order), or in order to enforce or apply the terms of any agreements we have with or otherwise concerning you (including agreements between you and us) or to protect our rights, property or safety of our clients, employees or other third parties
